By paying your registration fee and accepting a guaranteed charity entry, you agree to the following terms and conditions:

Registration Fee

- I agree to pay a non-refundable registration fee of £80
- I understand that my place is not guaranteed until this fee has cleared
- I will inform Little Hearts Matter immediately if I am unable to take part in the event. All monies paid to Little Hearts Matter to this point may be non-refundable and treated as a donation

Donations & Payment Terms

- I pledge to raise a minimum of £2000 for Little Hearts Matter though my participation in the event
- I understand that all sponsorship monies must be paid to Little Hearts Matter within 30 days of the Event taking place
- I will use a sponsorship form to collect details of my offline sponsors and any possible Gift Aid declarations and send these to Little Heart Matters following the event
- I will, in the sum of £2500 has not been paid within one month of the event date, pay the remainder from my own personal funds within one month of this date or in instalments to be agreed with Little Hearts Matter in writing
- I understand that Gift Aid cannot count towards the £2000 minimum sponsorship total

Fundraising

- I will collect money for Little Hearts Matter in connection with the event
- When using Little Hearts Matter collection boxes, buckets or sponsor forms, all the money collected in those tins or pledged on the forms will be donated to Little Hearts Matter within one month of the collection date.
- I will only use lawful means to fundraise for Little Hearts Matter and will not do anything that is likely to harm Little Hearts Matter's reputation
- My fundraising will not include door to door collections, street collections (without obtaining written
 permission from the local authority), collections on private property (without first obtaining written
 permission from the property owner), or conducting a raffle or lottery at a public event
- I agree that Little Hearts Matter can terminate my authority to fundraise on their behalf at any time by sending written notice to the address given by me overleaf.

Personal data

- I give permission for the free use of my name, picture, image, feedback and comments in any future publicity, advertising or fundraising materials, including on the internet and social media sites
- I give permission for my personal data to be stored and used by Little Hearts Matter in connection with the organisation, promotion and administration of the event (you can opt out of being contacted with anything not related to the event)

Health, Safety and fitness

- I take part in the event at my own risk and will not hold Little Hearts Matter responsible for any accident, injury or illness sustained to the fullest example possible in law
- I will fully prepare myself for the physical challenge of the event and I will check with my doctor to ensure that I am medically fit to participate in the event
- I will comply with any health and safety guidelines and any other rules issued by the event organisers
